Richard Siberry QC has over 25 years' experience as an arbitrator in most areas of commercial arbitration. Now practising exclusively as an arbitrator, he sits as chairman, sole arbitrator, or a party-appointed or nominated arbitrator in LCIA, ICC, UNCITRAL, LMAA, SCC and *ad hoc* arbitration tribunals. He has also conducted an Expert Determination in a gas pricing dispute, and has sat as chairman of a Lloyd's Disciplinary Tribunal.

Within the last few years, he has acted as arbitrator in many major arbitrations in oil and gas and other energy-related disputes, in telecommunications, satellite and other technology disputes, and in insurance, banking, shipping, and shipping-related disputes.
